2. The text of the amendment adopted is as follows:


"ARTICLE I

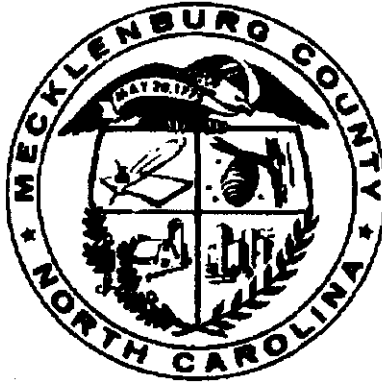
The name of the corporation is Wedgewood North Homeowners Association, Inc. (the "Association")."
